If accepted, Balance in full for ALL booth spaces must be received in our office no later than September 24, 2019. Cancellations after acceptance into the show will result in forfeiture of deposit and all monies paid to date. Failure to comply with all deadlines will result in automatic loss of booth space consideration. The PCCHA futurity Western Gift Expo is by invitation only and a completed application does not automatically reserve space.
